

The **Temple Christian College Photography, Filming & Audio Specific/Copyright Consent Form** is a special form required to support the ACS photo & Video Policy.

The ACS Photo & Video Policy is the policy adopted by Temple Christian College which oversees the manner in which we manage consent for photography, filming and audio content within the life of the school.

ABOUT THE ACS PHOTO AND VIDEO POLICY

Temple Christian College develops teaching, learning and promotional materials and publishes them in print and in digital forms as outlined within the ACS (Adelaide Christian School) Photo and Video Policy covering:

Digital - website, social media platforms, electronic direct mail, school apps, presentations

Promotional Material - curriculum booklets, printed flyers, posters, banners, local area advertising (print & digital)

School Publications - school year level photographs, student ID photos, annual year book

Specific/Copyright – third parties (Refer to ACS Photo & Video Policy)

The Adelaide Christian School Photo and Video Policy can be viewed via the Temple Christian College Campus Website. (Visit the School Policies Page via the School Life Menu).

The **Temple Christian College Photography, Filming & Audio Specific/Copyright Consent Form** is required where:

- School use of a student creative work is requested
- Use of a recording of a student is considered to be outside of the usual uses described within the ACS Photo & Video Policy including –
 - Provision or access by or to third party organizations
 - Situations where the identity and other personal information of the student is published

Consent given through the Specific/Copyright Consent Form only refers to the special circumstances outlined within the form.

The Specific/Copywrite Consent Form comprises of the following:

Section 1: Specific Consent for the use of an image, video, voice and or creative works as outlined

Section 2: Talent, Model & Performance Release for specific consent

Consent within this form is required to cover the following specific circumstance:

SECTION 1: SPECIFIC CONSENT TO USE IMAGE, VIDEO, VOICE AND OR CREATIVE WORKS

BY COMPLETING THIS FORM:

I grant specific consent for Temple Christian College to create and distribute material as outlined below that falls outside of the General Consent Section covered within the ACS Photo and Video Policy).

This specific/copyright consent covers the following material to be used by either, TCC, an external media and or third party not specified within the General Consent:

- Photographs, video or audio recordings of my child
- Samples of my child's work
- Image and name of my child when absolutely necessary

I acknowledge with my signature below that this permission will only apply to the specific circumstances outlined within this form.

SECTION 2: TALENT, MODEL & PERFORMANCE RELEASE CONSENT

I confirm and acknowledge that I give consent for my child to be photographed, recorded and/or filmed by Temple Christian College (TCC), an external media or third party for the purpose of the special circumstances as outlined within this form:

- TCC will own any and all rights in the photography, recording or filming.
- I hereby consent for TCC and/or its representatives, agents and related entities to use any photographs, film, videos or audio recordings of my child for promotional, commercial, and marketing purposes, whether or not accompanied by any narration or dialogue, by any present or future media or means known or unknown.
- I consent to the use of any printed material in conjunction with the abovementioned use.
- I hereby waive all personal rights and objections to, including the right to inspect, any use which will be made of my child's appearance by TCC.
- I hereby waive, release and forever discharge TCC and all persons acting under its permission or authority from all claims, actions and liability relating to use of the said photographs, videos or audio recordings.
- I understand that I will not receive any compensation or payment or any form of remuneration now or in the future in consideration for the above consent.
- Definitions: **Appearance** means the child's name, image, physical likeness, voice any and all attributes to the child's personality and/ or performance

Temple Christian College incorporates any successors, assigns or licensees including the Adelaide Christian Schools groups;

Use means lawful use and includes the exclusive and perpetual right of Temple Christian College in any jurisdiction nationwide to: (i) use, copy, adapt and/or exploit;

(ii) mix, edit, duplicate, or re-use, or create derivative works;

(iii) assign, license or sub-license;

(iv) publicise and/or market; and

(v) exhibit and/or perform and/or distribute by any present or future media, for profit or otherwise
