All students are allocated a laptop on a hire basis, the cost of which is included in the School Fees. The laptop remains the property of the School and is to be returned when the student leaves.

Hire of Textbooks

The hire of textbooks are included in the School Fees. Some textbooks are made available online and can be accessed on student laptops. Textbooks remain the property of the school.

The replacement cost of textbooks that are damaged or unreturned at the end of the school year will be charged to the school fee account.

Multiple Sibling Discount

For families with more than one child enrolled at the school, the following sibling discounts apply (to Tuition Fees only):

- Second child discount – 20%
- Third child discount – 40%
- Fourth & subsequent child -100%

EXPLANATORY NOTES

Fee Assistance

Fee concessions are available to families who consider they cannot meet the payment of full fees. A 'Fee Reduction Application' (available from your Campus Office) is to be completed and sent with proof of income to the Business Manager.

As a guide, a combined income of less than \$80,000 would be considered.

If you were previously approved for School Card, or if you are solely dependent on Centrelink benefits, you are strongly encouraged to apply for fee assistance.

A new application for fee assistance is required each year.

Building Fund Donations

Building Fund Donations are an important source of income which is used to build, redevelop and maintain school facilities for our students, staff and community.

All families are requested to donate \$200 per annum per family to the Building Fund. The school's Building Fund is endorsed by the Australian Taxation Office as a 'Deductible Gift Recipient' and any donations over \$2 are tax deductible. Annual Fee Payment Discount

A settlement discount of 5% applies if the Annual School Fees are paid in full by 9th February 2018, providing there is no outstanding balance from previous years.

Late Payment Fee

A late payment fee of \$25 will be charged if payment of school fees and charges are not made by the agreed due date(s).

Enrolment Withdrawal Terms Notice

One full term's written notice to the Campus Principal is required when a student intends to leave the school. Failure to give notice will incur a penalty of one term's school fees in lieu of notice.
