## Calculating Family Payments

Our Annual School Fees featured above represent the Year Level Fees that will apply to students attending Temple Christian College in 2020 before any discounts or fee concessions have been applied.

Contained within this document is the important information that will help you calculate your total family Annual Fee Payment for 2020.

## Multiple Sibling Discount

### Temple Christian College

For families with more than one child enrolled at Temple Christian College in 2020, the following Multiple Sibling Discount applies to the total annual school fee for each student.

- Families with 2 students.....20%
- Families with 3 students.....30%
- Families with 4 students.....40%
- 5th & subsequent students ..... FREE

### Bethany Christian School sibling Discount

A discount of \$452 per annum per family will be given if you have a student attending Bethany Christian School in 2020.

## Annual Fee Payment Discount

A settlement discount of 5% applies if the Annual School Fees are paid in full by 7th February 2020 providing there are no outstanding balances from the previous year.

## School Fee Concessions

Our passion at Temple Christian College is to provide a quality and affordable experience for every student seeking an authentic Christian education. Applications for fee concessions are available to families who consider they cannot meet the payment of full fees. A Fee Reduction Application Form is available from the Campus Office.

If you were previously approved for School Card or if you are solely dependent on Centrelink benefits, you are strongly encouraged to apply for fee concessions.

When assessing for fee concessions, eligibility is generally based on the household income, but many other factors such as the number of children are also considered. There is no income limit as such but as a rough guide, a **household income of up to \$80,000** would be considered for a single student. If your income is around this amount or higher and you have more than one child at Temple then you are welcome to apply as you may be eligible also.

The following table gives an indication as to how our fee concessions may impact annual school fees:

*Example of Annual School Fees for a single student following concessions:*

Year Level	Gross Family Income less than \$40,000
Year 7	\$3,000 - \$4,000
Years 8 to 10	\$3,200 - \$4,500
Years 11 to 12	\$3,300 - \$4,600

## EXPLANATORY NOTES

### BUILDING FUND DONATIONS

To help us maintain and develop school facilities for our students, each family is requested to contribute to the school's Building Fund on a voluntary basis.

While the set donation of \$240 per family (\$60 per term) will be most beneficial, all monetary donations are gratefully received. All Building Fund donations are tax deductible and contributions can be made along with fee payments.

### TEXTBOOK HIRE (INCLUDED IN FEES)

The hire of textbooks (property of the school) is included in the Annual School Fees. Some textbooks are made available online and can be accessed on student laptops.

The replacement cost of textbooks that are damaged or unreturned at the end of the school year will be charged to the school fee account.

### LAPTOP HIRE LEVY (INCLUDED IN FEES)

Year 7 to 12 ..... \$400 per year

All students are allocated a laptop on a hire basis calculated over a period of 3 years, the cost of which is included in the Annual School Fees. The laptop remains the property of the School and is to be returned when the student leaves.

### EXTRA CHARGES

Additional charges may be applicable for the following:

- Stationery pack (booklist)
- Some elective subject excursions and activities
- VET courses
- Music tuition and Instrument hire

## ENROLMENT WITHDRAWAL

### TERM'S NOTICE

One full term's notice is required to be submitted to the Campus Principal when a student intends to leave the school. Failure to give notice will incur a penalty of one term's school fees in lieu of notice.
